**NOTICE OF CONFIRMATION re: s53 WILDLIFE AND COUNTRYSIDE ACT 1981**

On 13 December 2019, the Gloucestershire County Council confirmed the above-named Order. The effect of the Order as confirmed is to modify the Definitive Map and Statement for the area by adding to them the following length of public footpath:

A length of public footpath in the parish of Bisley with Lypiatt Gloucestershire which commences at a point marked A on the Order Plan annexed hereto ("the Plan") at Ordnance Survey Grid Reference ("OSGR") SO 9048/ 0603 at its junction with Mount Pleasant (C200 road) in a generally easterly direction for approximately 68 metres to point B on the Plan at OSGR SO 9055/ 0604 at its junction with Van der Breen Street (41329 road) and shown by a broken black line on the said map and having a varying width of 1 – 2 metres between points A–B.

A copy of the Order and Order Map may be seen free of charge during normal office hours at Gloucestershire County Council, Shire Hall, Westgate Street, Gloucester GL1 2TG and Stroud District Council, Ebley Mill, Ebley Wharf, Stroud, GL5 4UB. The Order comes into force on the 13 December 2019 but if a person aggrieved by the Order desires to question its validity or that of any provisions contained therein, on the ground that it is not in the powers of Section 53 of the Wildlife and Countryside Act 1981 ("the Act") or on the ground that any requirement in Schedule 15 of the Act has not been complied with in relation to the Order he or she may under paragraph 12(1) of the said Schedule 15 within 42 days from the date that this notice is published make an application for the purpose to the High Court.

This Order is made by Gloucestershire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that Authority that the Definitive Map and Statement of Public Rights of Way for Gloucestershire requires modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) namely the discovery by the surveying Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonable alleged to subsist over land in the area to which the map relates being a right of way as described in Part I of the schedule hereto

The Authority has consulted with every Local Authority whose area includes the land to which the Order relates. The Gloucestershire County Council hereby Order that:

1. For the purposes of this Order the relevant date is 4 October 2019
2. The Definitive Map and Statement of Public Rights of Way for Gloucestershire shall be modified as described in Parts I, II and III of the Schedule hereto and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Wildlife & Countryside Act 1981, The Definitive Map of Public Rights of Way for Gloucestershire – Additional Public Footpath linking Mount Pleasant & Van der Breen Street, Bisley with Lypiatt Parish - Modification Order 2019"

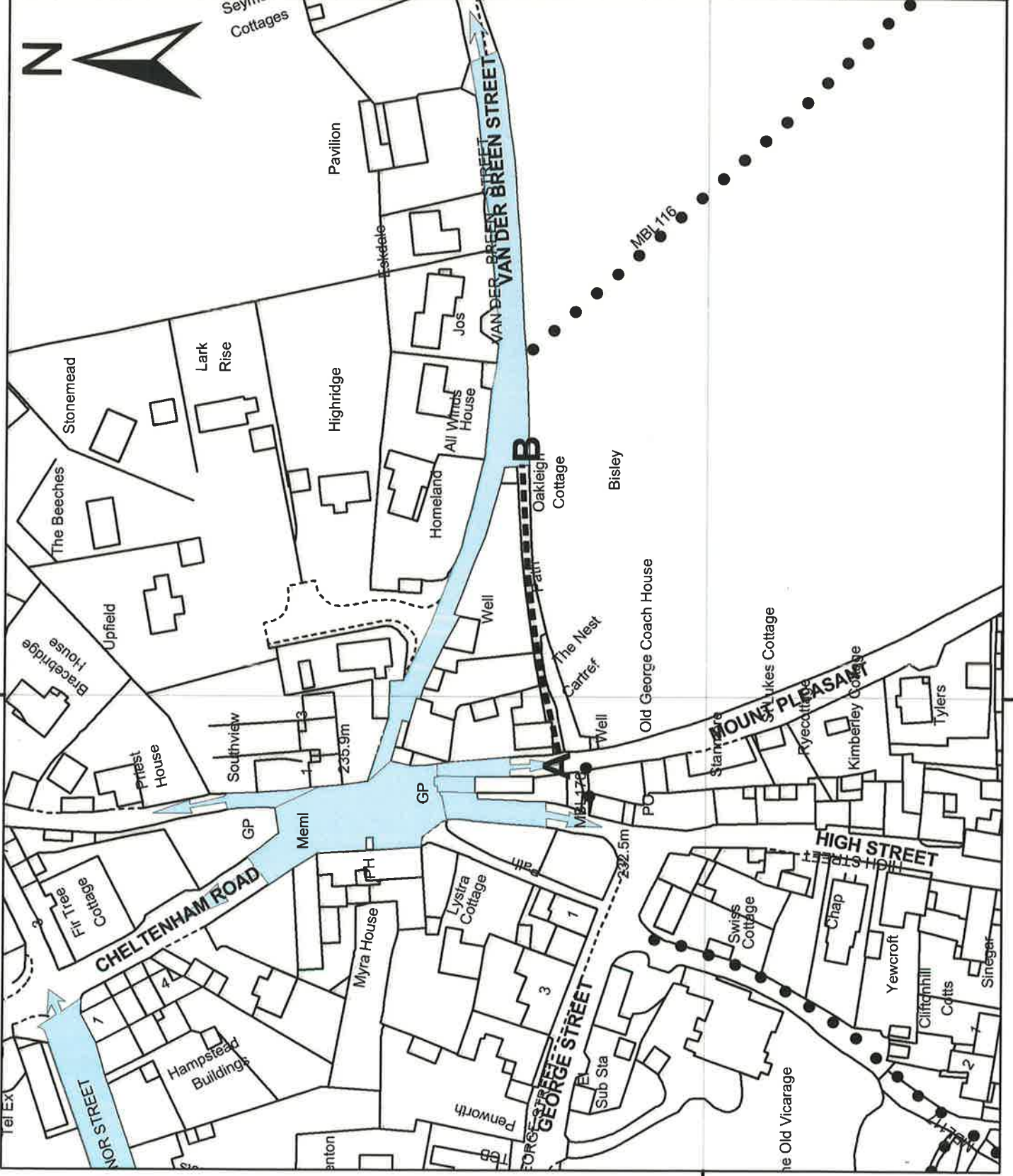
