

GLOUCESTERSHIRE COUNTY COUNCIL
TEMPORARY TRAFFIC ORDER
3/202 HOLLOWAY ROAD TO BAKERS MILL ROAD (PARISH OF BISLEY WITH LYPIATT)
(STROUD DISTRICT) ORDER 2018

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for the road set out in the Schedule below within the Stroud District ("the Road") is satisfied that use of part of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road;
2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls in the Parish of Bisley with Lypiatt within the Stroud District and in the County of Gloucestershire;
5. This Order shall come into operation on the 2nd day of May Two Thousand and Eighteen and shall continue in force for a period not exceeding eighteen months;
6. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order 3/202 Holloway Road to Bakers Mill Road (Parish of Bisley with Lypiatt) (Stroud District) Order 2018".

Road Closure

3/202 Holloway Road to Bakers Mill Road from the Oakridge Crossroads to its junction with Bakers Mill for a distance of approximately 860 metres.

**TEMPORARY CLOSURE OF 3/202 HOLLOWAY ROAD TO BAKERS
MILL ROAD (PARISH OF BISLEY WITH LYPIATT) STROUD
DISTRICT**

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the 3/202 Holloway Road to Bakers Mill Road from the Oakridge Crossroads to its junction with Bakers Mill for a distance of approximately 860 metres.

The reason for the closure is to carry out resurfacing works.
