Matters for Discussion

a) **Windyridge – Affordable Housing**

Mr Perkins told the meeting of the need to up-date the appraisal in order to ascertain the housing needs now and in the foreseeable future. e) **Gloucestershire County Council Highways Maintenance Best Value Review**

This very lengthy document had arrived in the middle of the month and required comments by the 31st May. Members who had a chance to read this were not impressed with its contents and the Clerk was asked to reply indicating this and the time scale allowed

Planning

Discussion took place regarding an appeal against a rejected planning permission applied for by a parish councillor. It was agreed that a meeting will take place in order that the revised plans and a presentation may be put before representatives of the Planning Sub-Committees after which those members without any interest could consider the matter before submitting an opinion to Stroud District Council Planning Department.

The following applications had been received and the following were the Council's responses during the last month;

Juniper Slad, Hay Hedge Lane, Bisley – Erection of garage - Support : Comments – Please confirm roof covering to be Bradstone reconstructed Cotswold tile not slate as indicated on application.

Holcombe Cottage, Bisley – Erection of two storey extension and detached garage with store room over - Support : Comments – Consent should be conditional subject to the garage and store room not forming separate/additional living accommodation in the future.

Wild Acre, Vanderbreen Street, Bisley – Erection of two storey extension and single storey extension – Support

Badgers Brook, Bismore, Eastcombe – Application for a new window in first floor north west elevation (Revised Plans) – Object – This window would overlook and adversely affect the privacy of the neighbouring property Little Orchard. In the original plans consent was given for a small window in this elevation with several conditions including opaque glazing. In the recent appeal (Ref APP/C1625/A/01/1078398) the Inspector's decision allowed the removal of this gable window and the replacement with a rear facing

dormer window (which has already been built). The clear assumption is that the rear facing dormer window replaces the gable window and a new gable window in this elevation should not be allowed for the reasons stated above.

Huberts Cottage, Dr Crouch's Road, Eastcombe – Variation of conditions B & C attached to permission S.8262/L – Comments – We have no objection to the removal of the restriction requiring holiday letting only. The addition of another dwelling available as low cost rental accommodation in the village is to be welcomed.

Thomas Keble School, Eastcombe - Extension to Design/Technology Block – No observations

Butchers Arms, Oakridge Lynch – Erection of dwelling and garage. Erection of building to provide overnight accommodation for public house – Support – We support the building to provide extra accommodation for the Butchers Arms. We support the application for the dwelling but we have a number of comments :-

1. We would only like to see a small, perhaps cottage type, dwelling. We would not like to see another 'executive home'. We would like to see a small 'footprint'.
2. We would like to see the vehicle access onto the road on the Waterlane/School road because the other road carries both vehicle and pedestrian traffic to the shop. Pedestrian access is ok on to this road.
3. The consent for the dwelling should only be allowed as a condition of the accommodation.

Ward Matters

a) **Bisley**

- i) The Ward will let the Clerk have a snagging list for Kennedy's following the Water Mains work.
- ii) It was requested that potholes be repaired on Back Lane down to the Stirrup Cup and the road surface be improved.

b) **Eastcombe**

- i) Quotations have been received for the public notice board for the recreation ground. The Clerk was asked to place an order with Woodchester Kitchens at a cost of £195.00 + VAT and to chase whether or not planning permission will be required.
- ii) A quotation for the repair of the stone walls on the recreation field are still awaited – the clerk to chase. In the meantime, more damage has been done and there are now three repairs to be done.
- iii) Although BT appear to be under the impression that the Telephone Box on the village green has been repaired, this is not the case. The Clerk was asked to follow this up.
- iv) The Gas Board have still to reinstate the grass that they damaged – the clerk was asked to contact them again.

- v) There are still parking problems around the village green. The Clerk and the Chairman were asked to discuss these with the Highways Authority at their monthly meeting and write to the head of the primary school asking for the cooperation of the parents when collecting their children.
- vi) Mr Brooks told the meeting of the success of the visit by the French visitors during a twinning visit at the weekend.
- vii) Mr Brooks said that there was quite a lot of interest in the Parish Website and last month, over 300 people had visited it.
- viii) There have also been complaints from parishioners that since the introduction of recycling, only one rubbish bag is being left and this is insufficient. Calls to the Council do not appear to have any affect. Mr Le Fleming said that he would make enquiries

c) **Oakridge**

- i) The Highways Authority are to be asked to repair potholes at the pinch point at the top of Moons Lane and, also, the road edges at the top of Pike and through the bends at Tunley which now 'fall off' and car damage is possible.

- ii) Mr Bryant asked the Clerk to place the order for cones and tape to be put on the Village Green to deter car parking. The Chairman said that there were some posts in Mr John Davis' garage, which could possibly be utilised.
 - iii) The planting of the Headwell had been agreed with a contribution by the council of £50.
 - iv) The repair of the stone walling round the recreation field is now underway and it was agreed that the small opening should remain the same size.
 - v) All drains are in need of cleaning. The Clerk will contact the Highways Authority.
 - vi) The Clerk was asked to congratulate the grass cutting contractor of the excellent standard of work being undertaken.
 - vii) The Clerk was asked to chase the Highways Authority to get the verges cut as soon as possible.

- viii) Although most footpaths have now been cut, the refurbishment of the path to Lynch Cottage/Whiteway is urgently needed as it has become dangerous. The Chairman suggested that the Council approach the County Council to ask whether it would be possible for the Parish Council to undertake this work on behalf of the County Council with the County Council being responsible for payment. The Clerk will make enquires.
- ix) There is a bollard adjacent to Old Post Office Cottage which is broken and needs replacing – the Highways Authority to be notified.
- x) The Crooked Mustard Wall has collapsed onto the footpath – the clerk was asked to inform the County Council.
