## **5.** Public Participation – Members of the public were invited to address the Council

#### 8 members of the public attended

- The owner of Frith House explained the two applications that are currently with Stroud District Council (SDC) planning and reasoning. See below. RB explained to the resident the thinking behind the Councils response, which will be explained as part of agenda item 8. LG asked about the creation of a meadow. The resident explained that there was a misconception of the removal of the top soil and it has been done to add the spoil to it to create a wild meadow.
- A resident asked about the Waterlane application and whether a business is going to be run. RB explained than the position at the moment is not a change of use. No commercial activity is noted, they would need a separate application for running a business. MB explained that if they did conduct a business without permission, it would be a case for SDC enforcement. RB confirmed that the Council would add the comment to its response that no commercial activity should take place if SDC are mindful to approve the application.

• Mr Leach, who had already met with ME and JE, explained that the residents have no objection to the expansion of the school, just the position, which is overbearing and intrusive on privacy. Residents were assured that local consultation would take place during pre-planning. There was only a presentation on April 6<sup>th</sup> with two days to make comments. Mr Leach spoke of the evidence received that there is a security issue and the local police are already dealing with bad and inconsiderate parking. Another resident agreed and said it was a very rushed process, with no communication. Originally there had only been a 2 storey building facing the residents, which has now been changed to 3 storeys. Other options had not been explored with no explanation of why not explored.

## b) Ash die back and local council replanting

The Clerk explained the Gloucester County Council (GCC) Scheme and the deadline for applications for either whips on PC land or trees on highways land of 31<sup>st</sup> July. Action: LG to take forward.

#### c) Play Areas Inspection Report – Work required in each ward – timescales, cost etc.

ME explained that the majority of the work was about matting, which is in poor state, plus some minor things that need resolving. Anything above ground level is not inspected. It was agreed that the Council should look for another inspection company. HS said that within a month of the report one of the cradle swings had broken and the deterioration had not been identified. HS confirmed that the two cradle swings will be replaced and the bridge needs replacing. A quote to replace has been received but not as yet taken up. HS to put together a proposal for Bisley. HJ to look at the report to assess the Oakridge requirements. ME said there was to be a presentation on proposals to enhance the Eastcombe paly area and so it makes sense to undertake all the work together. Action: The

Clerk to advice the Council at the July meeting what the reserves stand at and circulate the bank balances.

Chalford have a planning Committee who go through all applications at a separate meeting, which is open to the public. Only the responses are noted at the full Council meeting, no discussions.
- ME introduced Emma Hammond, who will stand for co-option for Eastcombe Ward at the July meeting.
- ME informed the Council that Eastcombe Primary School have installed a time capsule and would like an official record captured so that in x number of years it can be opened. They are putting a plaque on the wall. The Clerk said a certificate could be produced and lodged with the Gloucester Archives.
