They stressed that the scout group would be happy with any solution which ensured their current access was not impeded. A visit to the Scout Hut was offered. LG, MB, JE and a resident accepted the offer. ME commented that any solution needs to be balanced in terms of the environment, time and costs. Cllr Hammond will report the survey findings at the May meeting.
