LG made comment concerning the report including the link on the Gloucestershire County Council (CBC) website, which would be useful for the Oakridge Community Orchard plan Expression of interest form Gloucestershire County Council

RB also commented on the closed footpath, which the Clerk confirmed had already been reported to GCC Permitted Right Of Way (PROW) department, who have said they will go out and look at it.

9. Matters for Discussion:

a) Oakridge Ward

I. Tennis Court - discuss the costs and alternatives.

RB has concern over the price, unreasonable based on the amount of fees received. He thought if the users wanted it upgraded they should contribute. Also there is a query also that what is proposed is actually required. BH to talk to users about the PC's general thoughts. She will also contact Mr Jeynes (who looks after the courts) to discuss alternatives and bring recommendations back to the November PC meeting. BH thought that the white lines need redoing and the weeds around the edge of the court need clearing.

- II. Waterlane Field Outline the new proposal
- III. Waterlane Allotments Outline the proposals to clear and maintain Items II. and III. were discussed together.

A meeting was held at the site with IG, the Waterlane allotment warden, the Clerk, MB, LG and a Waterlane resident H Jones, to discuss options for the allotments and the paddock. The following was agreed, depending on costs

- Clear allotments 5/6/7 and also the mid-section of 3
- Clear the paths from the entrance nearest to 1 and the path through to 5, onwards to 7
- Create a community orchard in 8
- Provision of water
- The paddock would be kept for agricultural use, as it is currently. Any changes to grazing for horses require a change of use. This area will become free for rent at the end of March 2024.

This work will be done in 3 stages

- Clearing
- Water
- Orchard

IG to obtain quotes for clearing the area and present for approval at the November PC meeting.

The Clerk to re send another termination letter to the tenant of allotment 8. MB had already feedback that planning would be needed to use a section of allotment 8 nearest Limekiln Lane as a parking area. It is only access as per the other allotments areas in the Parish.
