11.1Bisley:

- 11.1.1 There have been 3 complaints about the diversion of the Dillay Valley footpath into a permissive path. Cllrs plan to walk the route and contact has been made with other neighbouring parishes, the Ramblers Association, the Rights of Way Officer and Cotswold Wardens to highlight the issue
- 11.1.2 The community orchard held a successful wassail; a video is on the Parish website
- **11.1.3** A survey will be carried out on the KGV Pavilion to check insulation, guttering and other potential maintenance issues

11.2 Oakridge:

11.2.1 Agreement has been reached regarding the paddock rental at Waterlane

Action: Clerk to draft an annual tenancy agreement between the parties

- **11.2.2** Issues on drains, street cleaning and verges have been taken up with the Highways department
- **11.2.3** A meeting to be requested with the property owners in Far Oakridge regarding PROW arrangements across their land

- **11.2.6** Part of the stone wall around Far Oakridge allotments needs replacing; the Parish Council will complete this work when necessary
